## DELEGATE CONTRACT

To establish a standard of conduct befitting a gathering of Maryland student leaders, MASC has formulated the contract that follows. It is to be signed by all delegates attending the 2024 MASC Convention, their parents/guardians, and school principals.

1. Attendance at all functions is mandatory.
2. Delegates may not leave the official convention property at any time (*exception: overflow hotel via shuttle bus at designated times*)
3. Delegates may not drive private vehicles to convention or during the convention.
4. Delegates must wear their ID badges at all times during convention activities.
5. Alcoholic beverages and controlled dangerous substances are prohibited.
6. Smoking and possession of tobacco products are prohibited.
7. No skateboards, roller blades or water guns are allowed at the convention.
8. No pizza is to be ordered from outside of the hotel during the convention times.
9. Male delegates are **not** allowed in the rooms of female delegates and female delegates are **not** allowed in the rooms of male delegates.
10. No one under the age of 18 is allowed in the hotel health spa.
11. Each night, delegates are to be in their rooms by the scheduled time and obey lights out policy. Delegates must remain in their rooms until 7:00 a.m. each morning.
12. Delegates are financially responsible for any loss and/or damage caused by them at the hotel and conference center.
13. Delegates must be aware of fire evacuation and safety procedures.
14. All delegates are responsible to local, regional and state advisors.
15. In addition to the provisions of this contract, delegates are responsible to their local school and district policies as applicable.

**All luggage and personal items must be clearly marked with student's name, region and school.**

As leaders, we must be continually aware of our actions and their effects. In order to make an impact we must exercise an awareness of responsibility to ourselves, to the organizations with which we are associated, and to other people. This code was developed through a cooperative process involving the MASC Executive Board, state officers, and regional advisors.

### As leaders we will:

- \* Serve as role models to our peers and set an example for all to follow.
- \* Be inclusive of all students while advocating, involvement, and participation in various activities.
- \* Maintain a high level of respect towards others and ourselves.
- \* Strive to be committed leaders and encourage others to reach their full potential.
- \* Remember that part of our leadership responsibilities includes helping, training, and encouraging future leaders.
- \* Fulfill our role as a person whom others can count on and whose word is solid and trustworthy by refraining from cheating, stealing, or lying.
- \* Realize that our actions directly impact the integrity and credibility of MASC.
- \* Maintain the high integrity that MASC has achieved.
- \* Abide by all rules and procedures laid out by our host facility and organization
