Friend, my name is O'Marie Barnes. I am a student, advocate, business owner, and proud

Marylander fighting for fair, equitable, and common-sense education and resources for student success. Or in other words, *very helpful yapping*, for your benefit!

Now, let's talk about why I want the privilege of your vote and faith to become the next Student Member of the Maryland State Board of Education. To know my why, you must first learn a little about who O'Marie Barnes is, and why I'm motivated to do this work: I was raised in Temple Hills, Maryland, a small but mighty community that's taught me the value of education, and using your talents to overcome long odds.

For too many, however, those odds mean very little chance for success in the first place. This is why I'm dedicated to helping students receive the resources they need to not just get by but to get ahead. I've always been told that a "closed mouth is not fed", so I'm actively using my platform to speak up. I founded the Barnes and Scott Youth At Law, a youth-led Nonprofit organization dedicated to providing young people with the resources in law, politics, civics, and public policy to become changemakers and legal professionals. When I felt an obligation to represent young people in Annapolis, I sought and received an appointment to the Maryland Youth Advisory Council, a council established by the Maryland General Assembly to provide young individuals with a voice in advocating for policy. When I felt I could contribute to mentoring my peers, I led the steering committee for Mentor Maryland | DC's Youth Advisory Council. When I wanted to make a difference at the local level, I ran a competitive race for Student Member of the Prince George's County Board of Education. Now, I'm asking for your grace in granting me the honor of representing your values as the Maryland S.M.O.B.

My platform is centered around the shared experience we have as students in Maryland Public Schools. By focusing on:

Academics: Fight for the institution of in-person and digital (staffing accommodation) remedial courses for the foundation of the Math and ELA curriculums, confronting the COVID-19 learning gap and bolstering student comprehension and postsecondary preparedness.

Providing Transportation Support: Advocating for the Maryland State Department of Education (MSDE) to negotiate with local transit agencies, or compel Local Education agencies (LEAs) to negotiate with local transit agencies, to provide free fares from school for students, eradicating the transportation barrier for students.

Chronic Absenteeism: Recatorize illness out of the bounds of Chronic Absenteeism. If you are out of school healing a sickness, that would not count toward being chronically absent. This action, in conjunction with the broadening of the "Concentration of Poverty Grants," can deflate the rate of Chronic Absenteeism while compelling students to attend, and thrive in school.

Community-schooling: Using the advocacy pulpit to push the Board to take a unified stance for the broadening of the "Concentration of Poverty Grants", state grants that classify Community Schools and fund wraparound services across Maryland.

Hey, Maryland students! My name is Will Andrione, and I'm a junior at Severna Park High School in Anne Arundel County. I am very excited and genuinely honored to be one of your finalists for the Maryland Student Member position on the Board of Education. Together, we can create a future where every student feels empowered to succeed regardless of background.

I haven't always been invested and active in student leadership; up until a year and a half ago, I wasn't significantly invested in it. Yet all it took to get invested was something so simple: volunteering and helping my community. In the summer before my sophomore year, I began volunteering for a 501(c)(3) non-profit called 'Happy Helpers for the Homeless,' in the name of helping homeless individuals with food and other necessities. However, volunteering just those couple of times opened my eyes to the challenges faced by underserved communities. It ignited a fire within me to help individuals and communities who haven't been put in the circumstances to put themselves in a better scenario. Since then, every leadership position I've held, whether in civics, service, student leadership, or elsewhere, has been driven by a passion for addressing inequities and empowering those who need it the most.

I'm running for Maryland State SMOB – not about myself, the scholastic stipend, or "boosting" my resume. No, this candidacy is about all of us students in Maryland and elevating all of us. All across Maryland, we see challenges as diverse as the state itself. While these issues may vary from Baltimore County to Somerset County to Montgomery County and beyond, the core issue remains the same: not every student has an equal chance to succeed. Whether this be individual student inequities or inequalities with whole communities, the point remains that there needs to be action to bridge gaps from student to student. Whether that be gaps in post-graduation success, the need for more substantial college and career readiness, or struggles with mental, physical, social, and overall wellness, and seeing how we as students and the Board of Education can improve that. My goal is for every student to feel confident that their school is preparing them for the future while supporting them and their well-being regardless of where they live or their background.

Though I am one person, and I don't experience the inequalities, issues, or concerns that other students face, considering Maryland's diversity, there are so many different issues that students have. My focus is not on the problems I have personal experience with; it is on every issue students face, which means hearing from them directly. I will fiercely advocate for a deep student advisory council, not just with one or two members from a region. However, multiple middle schoolers and high schoolers from every county were discussing issues specific to their region and statewide and advising me on the impacts on their county. The advisory council would serve as a way for me to hear from the counties **and** for the counties to hear from me. Every county and student deserves to know what the MD State Board is doing and working on from somebody on the board, and the SAC would also serve as a liaison back to the counties, explaining what is going on and how they will be impacted. This is imperative; transparency is key because no matter where you live, you have the right to know how you will be affected by the decisions that happen at the state level.

Life is hard for many people, and countless more are left underrepresented and underserved; now it's time to put them first and uplift them to create a more equitable education. It's not going to be easy, and it's not going to be done by myself. However, through passion, dedication, the advisory council, and student leaders making their voices known, we can create a Maryland where every single student, when they enter school or when they are walking the stage at graduation, knows that their education system did everything they could to prepare them and protect their health and safety. Thank you so much for your support. It's time to build a brighter future for Maryland – together.
