



2024—2025 NASC National Student Council Guardian Permission Form

The following agreement is designed to protect all participants including students, guardians, parents, and NASSP. You, as the student participant and your parent (or legal guardian), must sign this form to indicate agreement and or permission to participate in NASC National Student Council virtual meetings and the in-person National Student Council Event (the “Event”) to be held in Washington, D.C. March—April 2025, specific dates to be determined.

General Release: I/(we) understand that participation in NASC is entirely voluntary and that any program of travel involves some element of risk. I agree that, in consideration of National Association of Secondary School Principals (“NASSP”) hosting my attendance at the Event, I will not (including my parents, guardians, and legal representatives) attempt to hold NASSP, its board of directors, officers, employees, or agents liable for any injury, death, or loss to person or property sustained by me while participating in or arising out of any travel or activity associated with the Event.

I/(we) understand that NASSP is not responsible for chaperoning me while traveling to and from the Event or when attending the Event (e.g., bed checks, enforcing curfew, etc.). I/(we) further understand that NASSP reserves the right to make cancellations and changes to the Event itinerary when NASSP deems it necessary.

Insurance Coverage: I/(we) understand that NASSP requires that I be covered by appropriate medical insurance and that I am financially responsible for such expenses. Signature below verifies that student participant is enrolled in an adequate insurance program and that I/(we) will provide emergency contact information to NASSP.

Medical Treatment: I/(we) understand that while I am traveling an emergency may develop which necessitates medical care, hospitalization, or surgery. Therefore, in the event of illness or injury, I/(we) authorize NASSP staff to secure any necessary emergency medical treatment including the administration of an anesthesia and surgery. I/(we) understand that such treatment shall be solely at my expense, and I agree that I am responsible for any expense that might incur on account of my injury or treatment.

Conduct: I agree to conduct myself in a safe and prudent manner while participating in any activity or travel associated with the Event. I understand that all student participants are subject to program guidelines and regulations, and relevant state and federal laws and that in the event of violation of these or other behavior which is deemed by NASSP to be detrimental to participant or others, NASSP may immediately dismiss me from the Event and require me to return home. I also agree not to deviate from the proposed program itinerary without the expressed permission from NASSP staff. I understand that while attending the Event, I am subject to the NASSP's guidelines and regulations in effect (***include here if we have them***). I further agree to indemnify, defend, and hold harmless NASSP from any breach of these representations.

Photographs and Videos: I/(we) hereby give consent to NASSP and its corporate sponsors to use photographs and videotaped images of me for promotional, editorial, and advertising purposes related to the mission of NASSP.
