Representing: We need to guarantee that every student in the state's voice will be heard when shaping all of MASC's policies, activism, and plans. I would host several divisional caucuses and establish an Education Policy Committee to monitor Board of Education policies across the state. This would ensure that we can see representation from a more diverse group of students, especially on pressing issues like equity in education and school safety.

Including: We represent nearly 900,000 students from every corner of the state, and our leadership team should reflect that. I would work to **establish the roles of Rural Affairs Coordinators for the eastern shore and western MD**. They would help bridge the gap in rural student participation and ensure all voices are heard.

Supporting: Many schools and students want to be involved but don't know where to start. I would work with the Divisional Liaisons to **contact every single school's advisor, principal, and leadership team**, to ensure they have the resources needed for more engagement. We would also expand our middle school outreach and encourage early exposure to leadership opportunities.

Engaging: Advocacy is active, not passive. We should work to create more accessible and interactive advocacy opportunities. From inviting policy makers to MASC events to engage with students firsthand, to holding town halls with current and potential office holders. We should also work to have more engagement on the school level. Putting in more work to promote our conferences and events to a wider array of students.

We can work towards creating a more diverse and impactful MASC. I am ready to put in the work, and I hope to earn your support in this journey. Let's R.I.S.E. together and build a more inclusive and impactful MASC!
