

# 2026 MASC Convention

## DELEGATE CONTRACT

To establish a standard of conduct befitting a gathering of Maryland student leaders, MASC has formulated the contract that follows. It is to be signed by all delegates attending the 2026 MASC Convention, their parents/guardians, and school principals.

### Convention Center

- **Attendance** at all convention functions is mandatory.
- **Supervised Movement:** Students must be accompanied by an advisor when walking to and from their hotel and the Convention Center.
- **Restricted Areas:** Delegates may not leave Convention Center property except during designated times when they may return to their hotel under advisor supervision.
- **Vehicle Use:** Delegates are prohibited from driving private vehicles to or during the convention.
- **Identification:** Delegates must wear their official ID badges at all times during convention activities.
- **Prohibited Substances:** The possession or consumption of alcoholic beverages and controlled dangerous substances is strictly prohibited.
- **Tobacco and Smoking:** Smoking and possession of tobacco products are prohibited on all convention premises.
- **Prohibited Items:** Skateboards, roller blades, water guns, or similar items are not allowed at the convention.
- **Food Restrictions:** Outside food may not be delivered or consumed within the Convention Center.
- **Financial Responsibility:** Delegates are financially responsible for any loss, damage, or destruction they cause to Convention Center property.
- **Safety Awareness:** Delegates must familiarize themselves with all fire evacuation and safety procedures, which will be reviewed at the opening session.
- **Compliance with School Policies:** Delegates remain subject to all applicable policies of their local school and school district.
- **Advisor Accountability:** All delegates are responsible to and must comply with instructions from their assigned advisor.

### Each school/region is responsible for their own students at the hotel.

As leaders, we must be continually aware of our actions and their effects. In order to make an impact we must exercise an awareness of responsibility to ourselves, to the organizations with which we are associated, and to other people. This code was developed through a cooperative process involving the MASC Executive Board, state officers, and regional advisors.

#### *As leaders we will:*

- \* Serve as role models to our peers and set an example for all to follow.
- \* Be inclusive of all students while advocating, involvement, and participation in various activities.
- \* Maintain a high level of respect towards others and ourselves.
- \* Strive to be committed leaders and encourage others to reach their full potential.
- \* Remember that part of our leadership responsibilities includes helping, training, and encouraging future leaders.
- \* Fulfill our role as a person whom others can count on and whose word is solid and trustworthy by refraining from cheating, stealing, or lying.
- \* Realize that our actions directly impact the integrity and credibility of MASC.
- \* Maintain the high integrity that MASC has achieved.
- \* Abide by all rules and procedures laid out by our host facility and organization
