

Maryland Association of Student Councils (MASC)

Historical Timeline

1946 Representatives from 14 Baltimore area secondary schools meet at Towson High School to discuss the possibility of forming a regional student government organization; Towson High School, Bel Air High School, Dundalk High School, Elkridge High School, Ellicott City High School, Baltimore City College, Glen Burnie High School, Sparrows Point High School, Kenwood High School, Catonsville High School, Annapolis High School, Jarrettsville High School, Franklin High School, and Sparks School are represented.

1947 The Maryland Association of Secondary School Principals (MASSP) holds a meeting, at the instigation of Mr. Nelson Hurley and Mr. Chester Katenkamp, to the student government proposal.

1950 The Birth of MASC - January: Mr. Maynard B. Henry, Principal at Towson Junior High School, is State Coordinator of student governments by MASSP; five regions are created with equal representation to the Executive Council and advisors are appointed for each region:

Western: Mr. Harry Poole
Southern: Mr. John Speicher
Central: Mr. Homer Elseroad

Upper Shore: Mr. Ralph Beachley
Lower Shore: Mr. George Carrington

1954 Mr. Felix Simon, "Uncle Si," is appointed as the first Executive Secretary of the Maryland Association of Student Councils (MASC) by MASSP.

1956 August: The first annual Student Leadership Conference is held at the Methodist Camp in Churchton for the purposes of "promoting leadership in student councils." This program becomes known as the MASC Leadership Workshop.

1958 Uncle Si resigns as MASC Executive Secretary, but continues in his role as Director of the MASC Leadership Workshop; Mr. Robert Gibson volunteers to serve as MASC Executive Secretary.

1959 The MASC Executive Secretary and MASC Leadership Workshop Director begin to receive financial remuneration for their services from MASSP.

1961 MASSP and MSTA begin an "unofficial" joint sponsorship of MASC; the position of MASC Executive Director is created as a part-time position at MSTA and Mr. Morris C. Jones is hired.

1962 MASSP and MSTA enter a formal agreement for the joint sponsorship of MASC.

The MASC Advisory Board is established by terms of the joint sponsorship to "offer advice and guidance to the student representatives from the associated schools in the state" Membership consists of four representatives of both MSTA and MASSP, the MASC Executive Director and the MASC Leadership Workshop Director.

1963 Mr. Robert G. Dexter replaces Mr. Morris C. Jones as MASC Executive Director. May: MASC holds first Advisor Workshop.

1964 The MASC Constitution undergoes revision.

1965 Mr. Oscar C. Jensen replaces Mr. Robert G. Dexter as MASC Executive Director.

1967 MSTA assumes full financial responsibility of MASC. A Junior High School Conference is sponsored by MASC.

1968 Membership to the MASC Advisory Board is expanded to include three students and a representative from the Maryland State Department of Education.

1969 June: Perry Hall High School in Baltimore County hosts the National Association of Student Councils (NASC) Conference.

- Mr. Carter L. Hammersla replaces Mr. Oscar C. Jensen as MASC Executive Director. The MASC Constitution undergoes revision.

1971 July: Money is made available from the Maryland State Department of Education (MSDE) for MASC's administrative expenses.

1972 MSDE assumes sponsorship of MASC from MSTA; Mr. Eliot Pfanstiehl is named MASC Executive Director (separate document with details)

- The MASC Leadership Workshop becomes an independent entity known as the Maryland Leadership Workshop (MLW).
- MASC begins to hold two conventions each year: one in the fall and one in the spring.
- MASC begins an unwritten tradition of electing a middle level or junior high school student to the position of MASC Second Vice President.

1973 In response to the change in sponsorship, the MASC Constitution undergoes a major revision.

1974 In response to Bylaw 732:1 which requires local school systems to develop a comprehensive code of student rights and responsibilities, MASC publishes a folio, containing a model code, legal reference and precedence, and bibliography, in order to empower student leaders to take an active role in the process.

- Uncle Si retires as MLW Director, but stays active in the state organization.

1975 Mr. Randall "Randy" Lake replaces Mr. Eliot Pfanstiehl as MASC Executive Director.

- MLW incorporates.

1977 The position of MASC Executive Director becomes vacant for a period of 18 months. Mr. Mike Michaelson, Montgomery County Region of MASC (MCR) Regional Advisor; Dr. Malcolm Dutterer, Associated Student Congress of Baltimore City (ASCBC) Regional Advisor; and Mr. Don Murphy, Prince George's Regional Association of Student Governments (PGRASG) Regional Advisor, assume the duties of the Executive Director. MLW provides clerical assistance.

1978 Mr. James Gordon is hired to serve as MASC Executive Director.

1981 Spring: Mr. James Gordon proposes a one-year moratorium on MASC Conventions to the State Superintendent of Schools after an unsuccessful and ill-planned Fall conference at Northwestern High School. The proposal fails; however, the incident serves as impetus to revise the convention program from two annual conventions to one and also clearly defines the “sponsorship role” of MSDE to MASC.

- Fall: Mrs. Sue Ann Tabler replaces Mr. James W. Gordon, Jr., as MASC Executive Director.

1982 January: MASC sponsors the first of two conferences that will be held in conjunction with the 90-day session of the Maryland General Assembly; these one-day, drive-in conferences are known as Legislative Sessions.

- February: Legislative Session, session #2, becomes the MASC Constitutional Convention; a new constitution is created and accepted as an amendment to the Constitution of 1973. Qualifications for the position of MASC Second Vice President include being enrolled in a middle level or junior high school during the student’s term of office.
- Advisors in Maryland attempt to form and incorporate an advisors’ association known as the Maryland Association of Student Council Advisors (MASCA).

1984 MASC sponsors the first Presidential Mock Election with participation from 92,568 students across the state. Maryland Association of Student Council Advisors (MASCA) becomes defunct.

1985 Spring: The Maryland General Assembly passes Senate Bill 72 which creates the position of student member of the Maryland State Board of Education. The law provides that MASC and the Governor’s Youth Advisory Council may both nominate two students for the Governor’s consideration for appointment to the non-voting student position.

- Fall: Ms. Gael Butcher replaces Mrs. Sue Ann Tabler as MASC Executive Director.

1986 A committee is formed to revise the MASC Platform to ensure that the Platform and all MASC lobbying positions are consistent; a specific procedure is established for the annual revision of the Platform.

- March: A group of advisors meet at the MASC Convention and decide to revive the Maryland Association of Student Councils Advisors (MASCA); Mr. Harry Slaughter, SGA Advisor at Annapolis Middle School, is elected president. Apparently, this would be the last attempt to form an advisors’ association. MASCA once again became defunct by or about 1990.

1988 Fall: Dr. Susan Nash Travetto replaces Ms. Gael Butcher as MASC Executive Director.

- MASC sponsors the second Presidential Mock Election with a student forum/rally held at the Baltimore Convention Center the evening of the election to announce Maryland’s results.
- MASC began to publish a short-lived newsletter known as The Navigator. The Navigator appeared to be remnant of an earlier newsletter, The Gavel, which was published four or five times annually during the late 1960’s and 1970’s.

1989 Winter: MASC decides to hold only one Legislative Session per year.

1990 MASC creates a student council awards program known as the Felix Simon Award for Student Council Leadership and Service.

December: MASC sponsors the first annual Junior-Intermediate-Middle (JIM) School Conference at YMCA Camp Letts.

Two issues of an unnamed newsletter are published during the 1990-91 school year.

1990 In a logo contest, the current MASC logo is designed by Dana Brown, a student in Harford County.

1992 MASC Executive Board decides to revise the Platform every other year at the Legislative Session.

- MASC sponsors the third Presidential Mock Election with a student forum/rally held at Edmondson/Westside High School in Baltimore City the evening of the election to announce Maryland’s results.
- MASC begins to publish The MASCommunicator, a bi-monthly newsletter.

1993 Spring: Passage of House Bill 585 grants limited voting rights to the student member of the Maryland State Board of Education; it also removes the Governor’s Youth Advisory Council as a nominating organization. (The Governor’s Youth Advisory Council became defunct in the late 1980’s).

- June: MASC releases the results of its research project concerning the involvement of students to secondary level school improvement teams (SIT).
- Dec: MASC sponsors first annual Federal Training Session for trainers of the MASC Legislative Session.

1994 Spring: MASC forms formal partnership with MLW, Inc.

December: MASC holds first annual Student Education Forum at MSDE.

1995 Legislative Session was postponed due to snow.

- MASC Convention was held at the Carousel Hotel for the final time.

1996 MASC celebrates its 50th Anniversary.

- MASC stops Federal Training for Legislative Session.
- MASC holds a Mock Election Extravaganza for the presidential election.

1997 Fall: Ms. Catherine McCall replaces Dr. Susan Nash Travetto as MASC Executive Director. Ms. McCall is the first alumni of MASC to be appointed as executive director

1998 MASC begins the Dr. Susan Nash Travetto Friend of MASC Award.

- Over 1300 delegates and advisors attend the MASC Convention, making this the largest Convention ever.
- Role-alike meetings are started for the Executive Board at Executive Board meetings.
- Oct 1998 - Held the first statewide Mock Election event for the 98 Gubernatorial election
- Formally partnered with the Maryland Children’s Initiative and successfully lobbied the General Assembly to increase the tobacco tax, which led to \$700 million going to education funding.

- Hosted the AIDS Quilt and organized a tour of the regions.

1999 July: MASC hosts its first Staff Development Day

2000 February: MASC hosts its first Legislative Lobbying Day

- March: MASC hosts its first Convention Orientation Training
- MASC revamps its platform
- Pete Mahon (CCASC) Named NASC Region 2 Advisor of the Year
- Bryant Hall (CRASC) Selected NASC Region 2 Representative

2001 Baltimore City Student Board Member Gains Partial Voting Rights

- Ms. Shawn Stelow replaces Catherine McCall as MASC Executive Director

2002 March: MASC Co-Hosts NASC Region 2 LEAD Conference

- Ms. Camille McCann (PGRASG) Named NASC Region 2 Advisor of the Year
- Maryland State Board of Education Votes 12-1 to Support Full Voting Rights for the Student Member on the State Board of Education
- MASC along with Safe & Sound Organization, hosts a Youth led Gubernatorial Forum. Democratic Candidate Kathleen Kennedy Townsend and Republican Candidate Robert L. Ehrlich participated in the program at Baltimore Polytechnic Institute High School.
- The first edition of a middle school newsletter, The Seeds of MASC, is produced.

2003 MASC sponsors its first High School Leadership Conference at Wilde Lake High School in Howard County

- Prince George's County Student Board Member regains Partial Voting Rights after state legislation removed the student member's voting rights. MASC was instrumental in helping to advocate for the return of the voting rights.

2004 MASC hosts its first MASC Educational forum and Dinner with the State Board of Education Night at the Baltimore Convention Center. This event was designed to give students a forum to discuss issues of concern with state Board members.

- The Principal of the Year award is renamed the Wayne Perry Principal of the Year award to honor Wayne Perry, longtime supporter and friend of MASC from Harford County
- Wayne Perry takes on the position of MASC Registrar

2005 Legislative Session is postponed due to snow. Registration for all MASC events is now done using an online database.

- Fall: Shawn Stelow is promoted to Chief of the Youth Development Branch of the MSDE. The MASC Executive Director position is vacant. Ms. Tracey Seabolt fills in temporarily until a new director can be named.
- MASC organizes over 1000 teacher kits, student kits, and family fun kits to send to the Louisiana Coast in the wake of Hurricane Katrina

2006 Spring: MASC hosts its 3rd General Assembly for the 2005-2006 school year at Legislative Lobbying Day in Annapolis, a first for the organization.

- April 2006: MASC hosts the NASC Region II Conference.
- Anthony Beckett (CRASC) selected NASC Region II Student Representative
- Summer 2006: Ms. Kimberly O'Kane fills the position of MASC Executive Director.
- Executive Board votes to have an official MASC Charity and chooses the Leukemia and Lymphoma Society for the 06-07 year.
- December: MASC co-hosts with PASC the National Association of Workshop Directors annual conference in Crystal City, Arlington, Virginia.

2007 Feb: MASC has its constitutional revision.

- March: MASC hosts the NASC Region II LEAD Conference in Baltimore County
- March: Madiba K. Dennie - the youngest person ever elected to serve as the MASC President
- July: Mrs. Nora Murray replaces Ms. Kim O'Kane as the Executive Director.
- August: The MASC Executive Board chooses Kids Helping Hopkins as the 2007-2008 State Charity.
 - The term "divisions" is created, using the original regional areas of MASC (Southern, Western, Central, and combining Upper Shore and Lower Shore to Eastern Shore) and appointing liaisons to focus on communications
- November 2007: CCSGA hosts High School Leadership Conference at UMBC's college campus, a first for MASC.

2008 April: MASC hosts NASC Region 2 Conference at Arlington Echo - "The Hats of Leadership"

- May: Governor Martin O'Malley signs Senate Bill 1, creating the Maryland Youth Advisory Council (MYAC), and writing MASC into State Law once again
- July: Nora Murray's position as Executive Director was decided to be a reduction in force due to budget constraints. The MASC Executive Director duties were absorbed by MSDE with Mr. Robert Murphy taking the lead and being supported by other MSDE Staff, Regional Advisors and the Officer Team.
- Sept: MASC Executive Board chooses The Arc as the year's state charity.
- Student Members on County Boards of Education are given the right to vote within MASC.
- Dec: Dorchester County is recognized as the twenty-first individually designated region within MASC.

2009 Feb: MASC supports all counties in their attempts to gain partial or full voting rights for the County SMOBs.

- June: Mr. Lance Ledebur is appointed the new MASC Executive Director under the Youth Development Branch at MSDE.
- Aug: MASC Executive Board chooses The Sidney Kimmel Comprehensive Cancer Center, Johns Hopkins (Sarcoma) as the year's charity.
- Nov: First Fall Leadership Conference held combining the Middle School and High School Fall Leadership Conferences.
- Dec: MASC hosts the first MASC Western Divisional Conference and MASC Health and Social Issues Forum
- Dec: Mrs. Karen Crawford, MCR Advisor, named Region Two Earl Reum Award winner at NAWD in Fort Lauderdale, FL

2010

- Mar: MASC revises Constitution and Platform
- Apr: State Student Member of the Board of Education's voting rights are extended
- Jun: MASC Hosts the first MASC Alumni Reception
- Aug: Training of Trainers is conducted at Advance.

2011 Aug: MASC chooses the Chesapeake Bay Foundation as its state charity.

- Dec: Mid-Winter Retreat and Executive Board meeting held at Arlington Echo

2012 Apr: MASC hosts Region 2 Conference, "Admirals of Leadership" at Arlington Echo. Christian Hodges (CRASC) is selected as the Region 2 Student Representative to NASC Executive Board.

- May: Due to a scholarship offer to an International Baccalaureate program, MASC President, Shobhit Kumar, has to resign and Devan Ogburn becomes the first sophomore to serve as MASC President.

2013 Feb: MASC sends delegation to NASC LEAD Conference in Arlington, VA.

- Aug: MASC holds Advance Retreat at Fairlee Manor Easter Seals Camp in Kent County for the first time.
- Aug: Mrs. Karen Crawford, MCR Regional Advisor, is officially named as the Assistant Executive Director

2014 Feb: MASC Legislative Session is hosted by Allegany High School in Cumberland, Maryland, the first time a major MASC event has been held west of Hagerstown.

- Sept: MASC is without an Executive Director for two and half months while MSDE was redoing contractual agreement. Lance Ledebur volunteered as interim.
- Devon Ogburn (past MASC President) and Kara Ritterpusch (MASC President) presented the Training of Trainers Workshops to the New Mexico Association of Student Councils in Albuquerque.
- Dec: MASC Executive Director, Lance Ledebur, named Region Two Earl Reum Award winner at NAWD in Phoenix, Arizona.

2015 Mar: MASC Convention held at Hunt Valley Inn for the first time since 1999.

- Jun: A delegation of 8 students and two advisors attended NASC in Albuquerque, New Mexico.
- Sept: Another break in service for three months as Executive Director's contract was being reevaluated. Lance Ledebur continued to serve until new contract late in December.
- Nov: MASC Fall Leadership Conference, Gaithersburg High School (MCR) is attended by over 500 delegates, highest attendance in ten years.
- Dec: Former MASC Executive Director, Nora Murray, current BCSC Regional Advisor is named the Region Two Earl Reum Award winner at NAWD in Niagara Falls, NY

2016 Feb: MASC had a large delegation attend the NASC LEAD Conference in Crystal City, Virginia, and had six teams present workshops.

- Apr: MASC held its annual conference back in Ocean City and then hosted the Region Two Conference a week later at River Valley Ranch in northern Carroll County (River Valley Ranch)
- Aug: Advance held at Smith Center in Montgomery County with highest attendance ever.
- Aug: Colleen Larsen (MASC President), Matt Talley (Chief of Staff), and Karen Crawford (Assistant Executive Director) spend a weekend in North Carolina conducting the training of trainers to the NCASC executive board.

2017

- Apr: Lance Ledebur finishes his term as Executive Director, but volunteers through June. Mrs. Karen Crawford, assistant executive director, assumes responsibilities until late July, 2017, when MSDE appoints Ms. Olivia Keithley as Executive Director. Ms. Keithley is the second MASC alumnus to be appointed as an Executive Director! (serving July 2017-May 2018)

2018

- Dec.: First Southern Divisional Leadership Conference
- March: First Women's Leadership Forum, hosted in Western Maryland
- April: MASC Safety Forum with Legislators – in Annapolis
- June: Assistant Executive Director Karen Crawford begins serving as Acting Executive Director

2019

- Jan: Assistant Executive Director Karen Crawford officially hired by MSDE as a paid acting executive director
- April: First Western Divisional Leadership Retreat (Garrett, Allegany, Washington Counties), hosted in Washington County
- Awards Recognitions: Begin recognizing one outstanding student leader from each region (selected by regions)
- Established the Karen Crawford Regional Advisor of the Year Award
- Begin recognition of a middle school and high school principal of the year and a project of the year award (selected by each region)
- May: Partnered with the National Student Council and NASSP for a Federal Advocacy Day
- Nov: MSDE hires Ms. Nicete Moodie as the paid part-time executive director

2020

- COVID 19 strikes – Pandemic – the spring convention is canceled, schools are closed, "stay at home" orders are issued, people are socially distancing – MASC conducts officer elections virtually. (Region 2 Conference is canceled). Student leaders are flexible and we soon started to conduct virtual events with outreach into areas where transportation had been an issue. Our major issues now are internet stability!!

2021

- January: First responders and nursing home residents have started getting vaccines!!
- **MASC is officially a 501c3 March 5, 2021** The articles of incorporation for MASC were filed with Maryland and became effective 3/5/2021.
- March: Schools are just starting to get back to “in-person” learning using a hybrid system. Many students will remain virtual the rest of the school year.
- MASC is still conducting all events virtually as large “in-person” gatherings are not permitted until the fall.
- MASC held several small “in-person” events: Officer Retreat and the August, December, February, and May Executive Board Meetings
- October: MASC is granted tax-exempt status as a 501c3 with the official date of exemption being March 5, 2021
- November: MSDE is no longer able to “sponsor” MASC and removes the funding for the part-time executive director
- MASC holds its first “in-person” conference at the end of April “Convention Part B” hosted by Richard Montgomery High School, Montgomery County – it includes the awards program and Lori Hayes is the guest speaker.

2022

- August: The executive board removed Dorchester, NESASC, and SESASC as regions in MASC – they have been inactive with no adult leadership for over a decade.
- All MASC events are offered in-person (except for divisional conferences, special webinars and forums). Executive Board meetings are hybrid (in-person with a live stream option for remote participation).

2024

- Legislative Session business incorporated into the Convention. A new Spring Leadership Conference is scheduled and incorporates the Awards Program and all State of the Region reports, State of the State from the MASC president, and the State student member on the Board of Education report, and a Hall of Ideas for schools to share successful projects/programs. Nicete Moodie steps down as executive director in June of 2024.
- June 2024 – Ms. Nicete Moodie steps down as executive director – Mrs. Karen Crawford steps in to fill the role (no qualified applicants)
- MASC adding additional staff support positions: Workshop Coordinator (Olivia Keithley), Middle School Coordinator (Jesse March), and Convention Coordinator (Jeremy Brown)
- MASC begins working with HelmsBrisco for our Convention

2025

- Reverting back to a Legislative Session (Winter Leadership Conference title for one year) as the SMOB nominees must be submitted to the Governor 40 days before the end of the MD Legislative Session – conference will now also spotlight all local SMOBs/SROBs/Commissioners
- Convention now moving to a model using the Convention Center and surrounding hotels – out of the “housing” business – schools/regions book/pay for their own rooms from a block contracted by MASC
- Major celebration of MASC’s 75th Anniversary at the 2025 Convention – commemorative pin, banquet, Anniversary Gala Dance
